In case of any change in the fee school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed fees nunds to the students.

Salary shall be paid as per declaration at the time of seeking recognition.

- No capitation fee and other charges shall be charged from the children/parents

- for admission without any discrimination based on religion, caste, race, place of birtho any other whimsical, shall not allow to run two schools affiliated by different board/council in the same premises, shall not close down the school or and exisiting class during the academic session without the prior approval of the appropriate authority.
